

Regulations for Asia University Subsidy for Encouraging Faculty Members to Apply for Research Projects

Article 1. In order to encourage the engagement of faculty in academic research projects, and to promote the accumulation of individual academic research capacity and upgrade the level of academic research, we enact the “Regulations for Asia University Subsidy for Encouraging Faculty Members to Apply for Research Projects” (hereinafter referred to as “the Regulations”).

Article 2. Grant candidates:

Receivers of the subsidy are university faculty members (including full-time faculty members, contracted faculty members, and researchers) who have applied for the research project by name of university.

Article 3. The strategy to encourage university faculty members to proactively participate in academic research is as follows:

1. To invite university faculty members who have had excellent achievement of executing the Ministry of Science and Technology (MOST) research projects to be the co-hosts of the project.
2. To encourage novice faculty to apply for “Research Projects of Novice Faculty.”
3. To encourage teachers to instruct students to apply for the “Ministry of

Science and Technology Scheme of University Undergraduate Funded Research Project.”

4. To invite experts in industry groups as the consultants of the Curriculum Committee and seek opportunities for cooperation through the introduction of consultants.

Article 4. Each applicant shall be awarded for NT\$5,000 for each project. Provided that the project is cancelled, the award will be revoked. If the project is accomplished, the instructor shall be awarded for NT\$5,000 for each project.

Article 5. Approval principles for the buyout of hours: buyout hours are limited to three hours each semester. Those who obtain approval for the buyout of teaching hours may not draw excessive hourly fees during the semester. Applicable to all academic research and industry-academia collaboration programs incorporated by the Office of Research and Development and hosted by this school.

Article 6. Any affairs not stating in the Regulations shall be pursuant to the related regulations set up by the University.

Article 7. The Regulations adopted by the Research and Industry-Academia Collaboration Development Committee and the Administrative Council shall come into effect after they are approved and promulgated by the President. Amendments must also undergo the same procedures.

Note: In the event of any disputes or misunderstanding as to the interpretation of the language or terms of this Regulations, the Chinese language version shall prevail.
