

Asia University Student Academic Research Incentives Regulations

Amendments of Articles 4 and 6 on Nov. 26, 2014 by the 4th Administrative Meeting of Fiscal 2014
and Passed on Oct. 28 2013 in the 1st R&D Meeting of Fiscal 2013
Announced on Dec. 19, 2014 per Letter Asia Confidential No. 1030015977

Article 1 This Asia University Student Academic Research Incentives Regulations, herein after referred to as the Regulations, is promulgated to encourage students' participation in academic research, increase academic research motivation and standard, and enhance the University's reputation.

Article 2 The incentives provided through this Regulations shall apply to journal articles published on domestic or foreign celebrated periodicals or international conferences.

Article 3 Criteria and implementation rules for published dissertation incentive application:

1. Criteria for application :

- (1) The author(s) of the published journal article must be a student of undergraduate or graduate program in our University with "Asia University" specifically identified. Incentive for each journal article is allowed once for one applicant and one journal article only.
- (2) A dissertation shall mean one entire journal article, which may not be used for multiple incentive applications and may not be divided by sections or chapters for the purpose of multiple incentive applications.
- (3) Translation and journalist essays are excluded from incentive application.

2. Dissertation incentives :

- Note :**
1. An international conference taken place in Mainland China shall be regarded as an “International conference organized by domestic entity.”
 2. Speeches given by at least three scholars of different nationalities are required for a conference to be considered as international, and the applicant is required to provide evidence.

Article 4 Despite a journal article may be written by co-authors, namely a teacher-student team, only one of such co-authors is eligible for incentive application. No repetitive application will be accepted. With our deduction of the ranking of our University’s teacher, the reward for student is given in accordance with the following tiers: 100% for the first author or corresponding author. 30% for the secondary author. 10% for the third author. No incentive is given to authors of the fourth and beyond.

Article 5 The budget is provided by the Office of Student Affairs, which may adjust the incentive according to the given annual budget at its own discretion.

Article 6 This Regulation is passed in the Administrative Meeting and promulgated after approval by the president of our University. Amendment of the Regulation shall follow the same.
